Subject 153387953. Premium drone estimates premium increase of \$34.94/month. Calculated premium increase is \$22.81/month. No premium increase recommended at this time.

I attempted interviews with five individuals in the proximity of the subject at the time of the drone assessment. I see no notable improvement to premium calculations from previous drone testing.

Additionally, public opinion remains very low, consistent with prior reports.

Recommendation: terminate alpha drone operations. Less invasive operations could be more favorable.
